The International Conference on Sustainable Recycling Technologies, SusRec'05, and the International Workshop on the Implementation of the WEEE Directive, Green Electronics 05, are two events being held in the frame of a 3 days joint meeting on recycling in the European Union from 20 to 22 June 2005 in Prague, Czech Republic.

## What is SusRec'05

The International Conference on Sustainable Recycling Technologies, SusRec'05 aims at establishing an information exchange forum about the state-of-the-art and the future trends in recycling in Europe. In the frame of this forum, present and future of Recycling in Europe will be analysed, focussing mainly on legislation, recycling technologies, status of the industry and research and the use of information technology.

The conference is structured into two days sessions, with the presence of relevant authorities and recognised experts from industry, research centres and institutional representatives at national and European level. In the agenda of the DAY 1, the vision of recycling of several waste streams in 2010 will be analysed, considering the role of legislation as driving force for promoting recycling practices and the implications of the Directives recently enforced for specific waste streams.

On the other hand, the EU funded (under GROWTH Programme of the $5^{\text {th }}$ FP) Virtual European Recycling Centre (VERC) will be presented as an initiative attempting to promote education, training and exchange and dissemination of information dealing with recycling, using the most recent advances in Information and Communication Technologies. The objectives of VERC include also serving as a reference point to facilitate the contact between industries (SME's) and researchers for an easier transfer of research results into industrial applications and as the vehicle to enhance a better coordination of R\&D efforts and expenditure related to recycling in Europe, offering a space for discussion and for showing their positions to the different recycling agents and decision makers during the formulation of future European waste strategies and policies.

The DAY 2 programme is arranged into several parallel sessions focused on WEEE, ELV, Packaging, Plastics, Tyres, C\&D Waste and a wrap-up session and round table for discussion on main conclusions of the individual special sessions and the perspectives of recycling in Europe.

The goal of the International Conference will be:

- To give an update on the status of the state of the art in recycling from the points of view of manufacturers and recyclers.
- To give an update on the status of the implementation of the WEEE, Tyres, Packaging, Plastics recycling, ELV and C\&D waste directives.
- To compare state-of-the-art technologies in EU25 and to generate synergies.
- To networking and to create new research and developments programmes.


## Intended Audience

SusRec'05 is of great interest for recycling industries, administrative bodies, research and development providers, and environmental engineering and consultancy firms. The focus is on the use of information in the recycling business and state of recycling technologies. The conference is a new frame of reference for the consolidation and definition of strategies for recycling industry

## What is Green Electronics'05

## Why should you attend?

The production of electrical and electronic equipment is one of the fastest growing domains of manufacturing industry in the world. Both technological innovation and market expansion continue to accelerate the replacement process. New applications of electrical and electronic equipment are increasing significantly. There is hardly any part of life where electrical and electronic equipment are not used. This development leads to an important increase in waste electrical and electronic equipment (WEEE).

Therefore the European Parliament has passed a WEEE Directive on February 13, 2003, which has to be implemented into the 25 national EU member states' legislations until August 13, 2004. One of the main objectives of the present initiative is to increase the recycling of WEEE in order to preserve resources and disposal capacities, in particular landfill. On August 13, 2005 in most of the EU member states the WEEE Implementation goes live by starting the collection of WEEE under the new directive.

On the first day you will learn:

- the latest news on the different national Implementations of the EU legislation (especially in the new member states in Central and Eastern Europe),
- possible ways on how you can fulfil the national requirements as a producer and
- an overview of proposed and existing collective systems in the individual countries.

On the second day you will learn:

- the state-of-the-art in collection logistics,
- different re-use, recycling and recovery possibilities of products (white goods, consumer electronics, IT products) as well as components,
- a comparison between European and national approaches to fulfil the producer responsibility,
- the future of the electronics recycling industry facing new technologies (e.g. RFID),
- best practice examples in ecodesign of electr(on)ic products and
- what will be the state-of-the-art technology in the electronics industry innovation system.

Experts from leading companies and research organisations who are participating to the European Union (Growth) Thematic Network "ECOLIFE II - ECO-efficient LIFE cycle Technologies. From Products to Service Systems", to the EUREKA umbrella project "CARE Electronics Comprehensive Approach for the Recycling and Eco-efficiency of Electronics" and to "CONCEERN - CONex Central European Electr(on)ics Recycling Network"are looking froward to share their views on the State-of-the-Art and future perspectives in sustainability with you.
